WHEREAS, the Township Water and Sewer Engineer has recommended (see Schedule "A" attached) award of the contract to the lowest, most responsible bidder for the Water Treatment Plant Upgrades to MBE Mark III Electric Incorporated: \$2,189,079.00; and

WHEREAS, the Township Council has reviewed the design plans prepared by the Township Water and Sewer Engineer and the project design is approved by the Township Council in accordance with those plans, subject to field changes approved by the Township Water and Sewer Engineer and Change Orders approved by the Township Council; and

WHEREAS, the Council of the Township of Florence accepts the recommendation of the Township Water and Sewer Engineer, L. Russell Trice, P.E., of Richard A. Alaimo Association of Engineers.


NOW, THEREFORE, BE IT RESOLVED by the Council of the Township of Florence, County of Burlington, State of New Jersey, that the award of the contract for the Water Treatment Plant Upgrades is hereby awarded to MBE Mark III Electric, Incorporated, 213 Main Street, Madison, NJ 07940 as per the Township Water and Sewer Engineer's recommendation.

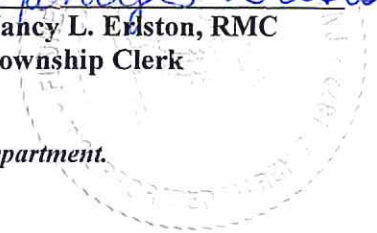

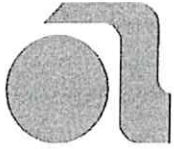
