**ORDINANCE APPROPRIATING \$60,000.00 FROM THE
CAPITAL IMPROVEMENT FUND TO PROVIDE FOR
THE PURCHASE OF WATER METERS AND
ACCESSORY EQUIPMENT IN AND BY THE
TOWNSHIP OF FLORENCE, IN THE COUNTY OF
BURLINGTON,
NEW JERSEY**

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF FLORENCE, IN THE COUNTY OF BURLINGTON, NEW JERSEY AS FOLLOWS:

Section 1. \$60,000.00 is hereby appropriated from the Capital Improvement Fund of the Township of Florence, in the County of Burlington, New Jersey (the "Township") to provide for the purchase of water meters and all accessory equipment therefor and incidental thereto.

Section 2. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This ordinance shall take effect as provided by the law.
