**An Ordinance of the Township Of Florence Amending Chapter
134 of the Florence Township Code to Establish a Stop
Intersections at Yurcisin and Bennett Streets**

Whereas, the Chief of Police of the Township of Florence has recommended that the intersection of Yurcisin Street at Bennett Street should be designated as a stop intersections, and

Whereas, the Township Council has considered the recommendation of the Chief of Police and determines that it is necessary to designate the intersection of Yurcisin Street at Bennett Street as a stop intersection in accordance with Chapter 134 of the Florence Township Code, and

Now, Therefore, Be It Ordained by the Township Council of the Township of Florence that:

Section 1. The Code of the Township of Florence is hereby amended by revising Chapter 134, Section 43, Schedule XI Stop Intersections to add the following provisions:

Stop Sign On
Yurcisin Street

At Intersection Of
Bennett Street

Section 2. If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.

Section 3. All ordinances or parts of ordinances of the Township of Florence heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 4. This ordinance shall take effect immediately upon final passage. Notice of adoption shall be published as provided by law.
