AN ORDINANCE OF THE TOWNSHIP OF FLORENCE AMENDING CHAPTER 134,
SCHEDULE XVI: LEFT TURNS PROHIBITED OF THE FLORENCE TOWNSHIP
CODE

WHEREAS, the Township is responsible for ensuring the safe travel of roadways within the Township; and

WHEREAS, the Township Staff and Professionals have recommended that left turns be prohibited at certain egresses along certain portions of West Front Street (CR 656) as well as right turns be prohibited along certain egresses of West Front Street (CR 656); and

WHEREAS, Township Council is in agreement with the recommendations of Township staff and recognizes that these measures will permit safe travel along West Front Street;

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Florence in the County of Burlington, State of New Jersey that Chapter 134 of the Township Code be and is hereby amended as follows:

ARTICLE I: AMENDED SECTIONS. Chapter 134, Schedule VI, Subsection of this Code, entitled "Left Turns Prohibited" is amended as follows"

1. §134-48-2 shall remain in its entirety and shall further be supplemented to read as follows:

Name of Street	Location
West Front Street (CR 656)	Facing the west side of B.179 L. 1.02, 1.03, 1.04, 1.05 (IPT WEST) left turns are prohibited from all driveways and all points of egress
West Front Street (CR 656)	Facing the east side of B.156.01, L.90 (IPT EAST) no right turns shall be prohibited

from all points of egress and
from all driveways

ARTICLE TWO. Repealer, Severability and Effective Date.

1. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
2. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
3. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
