**RESOLUTION OF MEMORIALIZATION FINDING
ORDINANCE NO. 2019-14
SUBSTANTIALLY CONSISTENT WITH MASTER PLAN**

WHEREAS, the Township Council introduced on first reading Florence Township Ordinance 2019-14 at its May 15, 2019 meeting;

WHEREAS, the Township Council referred Ordinance 2019-14 to the Township Planning Board for a determination and recommendation, in accord with N.J.S.A. 40:55D-26, as to whether the proposed ordinance is substantially consistent with or designed to effectuate the Township's duly adopted Master Plan Land Use;

WHEREAS, at the Planning Board's regular meeting on May 28, 2019, the Board reviewed the proposed ordinance;

WHEREAS, after discussion by members of the Board of the nature of the proposed ordinance which would regulate electronic pet containment fences, the Board adopted a finding that proposed Ordinance 2019014 , would be substantially consistent with the Master Plan; and

WHEREAS, the Board directed its Solicitor to prepare a report of its findings for submission to the governing body;

NOW THEREFORE, in reliance upon the foregoing it is hereby **RESOLVED** by the Planning Board of the Township of Florence, County of Burlington and State of New Jersey that proposed Ordinance 2019-14 is substantially consistent with the Master Plan and the Board's recent Master Plan Re-Examination Report, and would be in the public interest;

BE IT FURTHER RESOLVED that the correspondence of its Solicitor to the Township Mayor and Council, dated May 29, 2019 be and is authorized and adopted as the Board's statutorily required report of its findings.
