 AMEND FINANCIAL CERTIFICATION FOR CONTRACT  
 AWARD CONTRACT FOR THE 2019

**WHEREAS**, on May 15, 2019 the Township Council authorized the award of the 2019 Road Resurfacing Project to Richard T. Barrett Paving Co., 400 Prospect Street, Trenton, NJ 08618; and

**WHEREAS**, Resolution No. 2019-103 (copy attached) memorialized the contract award in the amount of \$938,885.25 and the full amount was charged to General Capital Ordinance No. 2019-10; and

**WHEREAS**, a small portion of the 2019 Road Program involved the wastewater treatment plant and sewer pumping station and the costs associated with this utility work was placed in the 2019 Water and Sewer Budget, and the Administrator should have noted the amount of the utility charges in the previous Certification of Funds for Resolution No. 2019-103; and

**WHEREAS**, after explaining the inadvertent mistake at the October 16, 2019 Council meeting, the Administrator asked that the township amend the Financial Certification for the 2019 Road Resurfacing Project so that it correctly reflects the amounts intended to be charged to both the above referenced General Capital Ordinance and to the Water and Sewer Department.

**WHEREAS**, this Resolution reflects the appropriate adjustment of charges under the below Certification of Funds, and this clarification does not alter the total amount of the contract award.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Township of Florence, County of Burlington, State of New Jersey, to accept the Administrator's request and approve the **adjustment** to the Certification of Funds as noted above and reflected in this Resolution.


