Council Representative Haas asked how this will work with the current Pilots. Administrator Sahol explained that the current Pilot will be extinguished once the building is razed. A new Pilot will have to kick in the minute there is a CO on the new structure. There is a 12-18 month bridge payment of sorts in between our agreement with the developer but the Pilot monies will be increased to over what present value is because the approved value is going to be much more.

Council President Frappolli asked if they decided to do away with the entire site and it were no longer there, then the municipality would get no revenues from it whatsoever other than land? The Administrator confirmed this is the case. The Administrator also explained that they own two substantial parcels to the rear of this property, one being on the same side of Bustleton Road as they are on. They are indicating that there is a willingness for a lengthy multi-year restriction on the property during which time nothing can occur and anything other than agriculture uses proposed will need a use variance. The other parcel is a very sizable property between Columbus Road and Bustleton Road and they are willing to work with us on a preservation method in which we would work with Burlington County. This is a good farming opportunity.

#### **Mayor**

Mayor Marter reminded everyone that the Patriotic Day parade is July 12<sup>th</sup>, June 19<sup>th</sup> is Juneteenth and that the Township offices are closed in observance of Juneteenth on Friday, June 20<sup>th</sup>.

#### **Administrator**

Council Representative Haas asked the Administrator about the survey stakes at the whirlybird. Administrator Sahol stated that he had a conversation with the Government Affairs Officer at the Turnpike earlier in the week and he thinks they are out there surveying in advance of proposing some corrections to the whirlybird issue that was recently brought to their attention. Administrator Sahol said the Turnpike is supposed to be reaching out in short order to get the parties together to discuss their findings.

Council Representative Loftin asked for an update on the carnival equipment that was left behind on Nyikita field. Administrator Sahol stated that the trucks were moved out of there earlier in the day and that it definitely won't happen again where they leave anything behind like they did this time.

### **UNFINISHED BUSINESS**

Council Representative Frappolli asked for an update on the issues at the playground. The Administrator stated that he hasn't heard much lately.

Council Representative Frappolli also mentioned that Marty is moving ahead with the grants proposal for the field house and looking at other parks moving forward. He also asked about the trees along the path past the church on West Fifth Street, he was under the impression that the trees were going to be planted all the way down to the park area. Administrator Sahol stated that he was under the impression that the trees were only going to go down a small portion across from RD Wood and then stopping like they have and that he will look further into that.

Council Representative Frappolli asked how people can donate trees to be planted in the township. The Administrator said they just have to reach out to make the donation and the Shade Tree Commission could make a recommendation of the type of tree and then do the installation.
