In regards to Ordinance No. 2022-01, Council Representative Marter asked if flat, raised crosswalks are proposed and not speed bumps. Administrator Fazekas confirmed that raised crosswalks will be installed at Walnut and Chestnut Streets.

Mayor Wilkie explained that Ordinance No. 2022-02 is one of the original ways that the state of New Jersey used to put restrictions on items on the appropriations side of the budget. They put a 2.5% cap in place and, if you wish to go to 3.5%, they require an ordinance be put in place.

REPORTS: ADMINISTRATION

Mayor Wilkie explained that, as part of our State Route 130 Endorsement, a vision statement is required to be presented to the Planning Board. In order to put that together there will be a public hearing and, obviously in the middle of Covid, the recommendation was to instead put out a questionnaire. A questionnaire has been developed by the Planner and that will be circulated, compiled and presented at the Planning Board meeting in March. It will be posted on our website and we will be reaching out to the schools in order to get as much information out there.

Administrator Fazekas stated that the NJDOT did go out to Route 130 and Delaware Avenue and increased the timing of the signal there during the evening hours coming from Delaware Avenue. He thanked Mr. Kamienski for his email and for going out to double check and confirm that the timing was indeed increased and 8-9 cars are getting through that intersection now compared to only four cars previously.

UNFINISHED BUSINESS

A. Main Street Parking Options

Mayor Wilkie explained that Main Street was originally planned to be paved on just the Hornberger Avenue side, but both sides are in deplorable condition from Second Avenue to Fifth Avenue (Main Street circle). In a conversation last week with the engineer, we asked if we should take the island out to provide more parking in that area. Eliminating the island would result in seven additional parking spaces. This is only a concept plan; no cost estimate has been done yet. If Council agrees and is serious about this, it would be included as an alternate in the Road Program. If Council does not wish to change the historic nature of the Village of Roebling, then we just leave it but he wanted to give Council a chance to discuss this.

Council Representative Ostrander stated that he thinks it disrupts and destroys the historic nature of the Village. Council Representative Marter had a different thought, she stated that this would at least allow parking in that area where we have a business district where parking is a real issue. Council discussed different ideas as to how to add parking in that area without changing the historic nature as well as the space issue.

After discussions, Council President Garganio asked Mayor Wilkie to look into who owns the concrete area in front of those buildings to see if parking would be a better idea there instead of disrupting the island. He also asked the mayor to find out where that right-of-way is on that road. Mayor Wilkie agreed.

Council Representative Haas asked if we were to go with what the engineer had drawn up, are we trying to get this in now as part of the road program or is it just a true alternate that we can get a price for and see what the options are? Mayor Wilkie explained that it is an alternate and that it has to be done as part of the road program. You can't do one without the other.

Mayor Wilkie will have the engineer take a look at some of Council's suggestions and ideas and it will be revisited.
