Council Representative Marter asked Council to help support the Thoroughbreds basketball team, created for high school students that may not want to go to college but want to play basketball. She stated that Burlington City and Edgewater Park have already written letters of support and the team reached out to her to see if she would write a letter. She is asking Council to support the idea of having a Burlington County basketball team. They have already spoken with Marty about doing some free clinics here for the students to be able to learn techniques. Council Representative Marter offered to reach out to the representative for the team if Council would like to know more about it.

Mayor Wilkie recommended that this issue be be referred to the Recreation Committee before Council acts upon it. This way the Recreation Committee can do the due diligence.

Mayor Wilkie read an excerpt from the April 24, 1891 Council Meeting minutes.

Mayor Wilkie thanked Council Representative Marter for her persistence with Congressman Kim. Administrator Fazekas followed up with them and we have now submitted for grants for two sewer pump stations and he submitted to the two Senators as well. There is no guarantee, but hopefully there will be some opportunity there.

Mayor Wilkie stated that Amazon is having a tree planting on Earth Day, Friday April 22nd at 10:30 a.m. at the field hockey fields. Shade Tree is doing the dedication of Michael's Grove at the end of Second Avenue on May 7th at 9:30 a.m. On April 30th the Roebling Museum is hosting their car show from 9 a.m.-3 p.m. and the Blue and Gold Banquet is at 2:30 p.m. at Riverfront School.

PUBLIC COMMENTS

Bryan Hewitt, 1080 Grove Street, mentioned that there may be some eligibility for state grants to help restore the old bank on Main Street in Roebling. The New Jersey EDA is hosting a webinar on May 12, 2022. There is \$50 Million that they are awarding in grants for up to 45% back in construction costs for repairing/restoring historic buildings and bringing them back to use. He knows that private parties are eligible but he is not certain if government is eligible but he thinks it is something that should be looked into to help restore the bank building. He shared the web address (historictaxcredit@njeda.com) with Council. Council agreed to have someone look into it.
