#### **PUBLIC COMMENTS**

Council President Garganio opened the meeting to the public at this time.

Jeanne Ondusko, 10 Olive Street, voiced her concern about an ongoing problem in her neighborhood. She stated that they have been dealing with stray cats and they are reproducing and becoming a nuisance. The ACO was asked to come out and trap the cats but she was told that she must sign a form stating that they will lend her a trap but that she must do the trapping and be totally responsible for the trap and any animals caught in the trap. They also give specific times and conditions as to when the traps can be set. She stated that according to N.J.S.A. 4;19-15.16, Bordentown Ordinance #2021-4, Bordentown's code chapter 6.12, Florence Township's code chapter 41 and the duties of the Animal Control Officer posted on Bordentown's website, it states the safety of residents, domestic pets, and wildlife are most important goal the officers work to maintain. It also states that the ACO enforces the laws governing domestic pets and wildlife and traps and transports feral cats, feral dogs and lost pets to local shelters and that the ACO responds to resident's complaints 24 hours a day, seven days a week. This is not being done and therefore they are failing to meet the needs of the people in the town and perform their duties. She stated that the health and safety and their pet's health and safety is being ignored and in jeopardy. When she refused to sign the form because she felt it was a safety and health issue for herself, she was told that they could not help her with the problem.

Administrator Fazekas stated that he will look into what can be done about this. Council President Garganio thanked her for coming in and stated that we will get back to her early next week.

Seeing no one else wishing to be heard, it was the Motion of Ostrander, seconded by Haas to close the public portion of the meeting. Voice vote – All ayes.

#### REPORTS OF COMMITEES, BOARDS AND OFFICERS

Council Representative Baldorossi mentioned that on June 6<sup>th</sup> the Recreation Committee brought up safety concerns regarding not having a fence on West Sixth Street at the park. He also mentioned that the former Public Works garage needs estimates to have the floor leveled and it has to go out to bid because it is over the threshold and they are asking when the bid preparation will be done.

Administrator Fazekas stated that he spoke to Public Works and they have fencing in the garage and it is on their list to install the fence there. And, in regards to levelling the floor in the public works garage, quotes came in well above our bid threshold. We would have to go out to bid and funding will have to be put in place in order to do that. We received \$70,000 for the grant that Marty applied for and we have used some of that money for other projects in there. As soon as we get the funding together for that, we will proceed with the bid and the Township Engineer will assist with getting bid specs together.

Council Representative Baldorossi also mentioned that the committee asked about the park planner and the scope of work that he is going to be doing and if other park and playground improvements are going to continue to happen while we are waiting because there are safety concerns.

Administrator Fazekas explained that any safety issues will be addressed immediately.

Council President Garganio asked, in regards to the floor in the public works garage, if there is a chance that we can go out to one of the co-ops so we don't have to go through the whole bid process and just get state contract pricing on that? Administrator Fazekas stated that we are looking into that and researching different co-ops to see if we can do that but we may be incorporating the funding with that to some other projects so it will be tied into one. Mayor Wilkie stated that he prefers that the architect be brought in.

Council Representative Marter stated that she is getting a lot of complaints about the speed in which vehicles are coming around the corner at DC Fabricators on West Front Street. She is wondering if we can put a police officer in that area and if it would help to have a speed sign on Front Street before they get to that corner. She also mentioned that she is getting complaints about the speed people are travelling on West Fifth Street.

Council President Garganio asked if speed humps would be a good option for slowing traffic coming around that corner and if that is something we can ask the county to do? Administrator Fazekas stated that he is not sure if they do speed humps on county roads but he is meeting with Joe Brickley and he will ask.

Council Representative Marter met with Rashauna Johnson, the owner of the Burlington Thorobreds basketball team, and she requested that we set up a basketball game with our Police Department and/or Fire Departments. She put a call in to Marty to see if we can get something organized in our town. She stated that at a press release recently she learned that they play internationally, not just locally within the state and she thinks that anything we can do would be a great help. She also mentioned that they are having a tryout that is open to everyone on July 10<sup>th</sup>.

#### REPORTS: ADMINISTRATION

## **Mayor**

Mayor Wilkie thanked Council for passing Ordinance No. 2022-08 and explained that this was the Holy Assumption carnival grounds which has now been transferred over to the school district. This was the goal when that property was purchased almost 10 years ago. Mayor Wilkie said that the school has mentioned putting bus pick up and parking there and the long-term goal is to construct an early childhood center on Parish Lane. It is not in next year's school budget but it is the ultimate goal.

Mayor Wilkie mentioned that the Bike Rodeo is Saturday, June 18<sup>th</sup> sponsored by the Police Department. The Roebling Garden Tour being put on by the Museum is on Saturday as well. Our Patriotic Day celebration will be held on July 9<sup>th</sup> with the flag raising starting at 11:00 a.m. at Oak and Fifth Streets and the parade starting at 12 p.m. And at 5:00 p.m. the vendors and concerts will be starting at the Municipal Complex with fireworks at dusk.

#### **Administrator**

Administrator Fazekas explained that we were awarded \$75,000 for the CDBG grant and project. Our base bid came in at \$104,000 so we are going to use money out of another ordinance that was just passed. He and Ted Lovenduski met with Ms. Hiros from the county and submitted paperwork to them. We will be awarded an additional \$20,000 from the grant so we will get \$95,000 total in grant money. He thanked the county and Ms. Hiros for working with us so we can continue with that project.

## **UNFINISHED BUSINESS**

A. Township Website

Council Representative Marter explained a few issues that she noticed with the township website to include not being able to search for topics easily, the information generated from the search is not current or relevant and they are no longer receiving email updates when something new has been added to the website. Rob Blanda along with his associate Laurie Steidle of Caddisart agreed to look into these issues and try and come up with solutions sometime in the next few days or so.

#### **NEW BUSINESS**

Council Representative Baldorossi asked what can be done about the old trees that are coming down and dropping branches and posing a threat to the community? Administrator Fazekas said that the tree service is out in Roebling trimming trees and getting all of the dead branches out but he will check with Ted Lovenduski and get an update for him.

Council Representative Baldorossi also stated that there are a lot of cars on the Avenues in Roebling and asked to have the curbs on the corners painted yellow to prevent people from parking too close to the corners and making it hard for drivers to see around them. Mayor Wilkie stated that we will see what can be done this year.
