**AN ORDINANCE OF THE TOWNSHIP OF FLORENCE
AMENDING CHAPTER 2 OF THE FLORENCE TOWNSHIP
CODE ENTITLED "FEES" SECTION 2-2 ENTITLED "SCHEDULE A" BOAT RAMP
AND DESIGNATED TRAILER PARKING AREA FEES**

WHEREAS, the Township Council of the Township of Florence, at their February 4, 2026, and February 18, 2026 meeting did discuss the concerns of residents regarding the use of the Florence Township Boat Ramp and Designated Trailer Parking Area and agreed to amending the Township's Fee Ordinance, based on recommendations of the Township Administrator as set forth herein.

NOW THEREFORE, BE IT ORDAINED by the Township Council of the Township of Florence that:

Section 1. Amend Chapter 2, Section 2-2 Schedule A, with regard to Boat ramp and designated parking area fees shall be amended to read as follows:

Item	Fee
Boat ramp and designated parking area fees	
Out-of-state resident	
Daily permit	Not eligible
Annual permit	Not eligible


Section 2. If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.

Section 3. All ordinances or parts of ordinances of the Township of Florence heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 4. This ordinance shall take effect immediately upon final passage. Notice of adoption shall be published as provided by law.
