ORDINANCE 2026-17

AN ORDINANCE AMENDING CHAPTER 43, ARTICLE II (CASUAL SALES)  
OF THE TOWNSHIP CODE OF THE TOWNSHIP OF FLORENCE  
TO ALLOW FOR SALES ON SUNDAYS

**BE IT ORDAINED** by the Township Council of the Township of Florence in the County of Burlington, State of New Jersey as follows:

**ARTICLE I: AMENDED SECTIONS.** Chapter 43, Article II Casual Sales, Section 43-23 entitled Conditions of License, is hereby Amended to read as follows with the prior language deleted in its entirety:

*Revised Language:* The casual sales license shall be issued to any one person or any one property only once within a six-month period, and no such license shall be issued for more than three consecutive calendar days. Where the applicant for the license certifies that the casual sale is being held because the resident of the property is moving, a second license may be issued within the six-month period. Each license issued under this article must be prominently displayed on the premises upon which the casual sale is conducted throughout the entire period of the licensed sale.

**ARTICLE II. Repealer, Severability and Effective Date.**

1. Repealer. Any and all other Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
2. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
3. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
