ORDINANCE NO. 2026-18

An Ordinance of the Township of Florence Amending Section 64-3 of the Code of the Township of Florence Establishing Construction Code Fees within the Township of Florence

WHEREAS, Chapter 64 of the Code of The Township of Florence, entitled Construction Codes, Uniform, sets forth, in Section 64-3 the fees relating to various construction, plumbing, electrical and fire safety sub-code permits in the Township of Florence, and;

WHEREAS, the Township Council has determined that it is necessary that the fees should be amended, and

WHEREAS, the Construction Code Official and the Township Administrator performed an extensive review of the fee structure.

NOW THEREFORE BE IT ORDAINED by the Township Council of the Township of Florence that:

Section 1. Chapter 64 Fees; report of the Code of the Township of Florence is hereby repealed in its entirety and replaced to read as follows:

§ 64-3. Fees; Report of the Construction Code Official.

[A.] General.

(1) The fee for plan review, computed as a percentage of the fee for a construction permit, shall be paid at the time of application for a permit. The amount of this fee shall then be deducted from the amount of the fee due for a construction permit when the permit is issued. Plan review fees are not refundable.

(2) The fee to be charged for a construction permit will be the sum of the basic construction fee plus all applicable special fees, such as, but not limited to, elevator or sign fees. This fee shall be paid before a permit is issued.

(3) The fee to be charged for a certificate of occupancy shall be paid before a certificate is issued. This fee shall be in addition to the construction permit fee.

(4) Where the Department, pursuant to N.J.A.C. 5:23-4.24, is designated as the plan review agency, or when the Department has been requested to provide plan review services by a municipality pursuant to N.J.A.C. 5:23-4.24, or when the Department is designated as the local enforcing agency pursuant to N.J.A.C. 5:23-4.3, the following schedule of fees shall pertain.

(5) Newly constructed residential units that are to be legally restricted to occupancy by households of low- or moderate-income shall be exempted from the fees as set forth in Subsections B and C below and otherwise payable to the Department.

(6) State of New Jersey training fee. This fee shall be calculated in accordance with N.J.A.C. 5:23-4.19, as amended and supplemented from time to time.

[B.] Departmental plan review fee. The fees listed in Subsection C(2) below shall be in addition to a departmental plan review surcharge in the amount of 20% of each listed fee. Where the Department performs plan review only, the plan review fee shall be in the amount of 20% of the new construction permit fee which would be charged by the Department pursuant to these rules.

[C.] Departmental (enforcing agency) fees shall be as follows:

1. Building Fees

A. New Construction and Additions

1. Fees shall be based upon the volume of the structure.
 - a. Volume shall be computed in accordance with N.J.A.C. 5:23-2.28.
 - b. Use groups shall be classified and defined in Chapter 3 of the Building Sub code as adopted by N.J.A.C. 5:23-3. Class of building shall be determined in N.J.A.C. 5:23-4.3A(d).
2. All use groups except as listed below in A3 & A4..... **.045** per cubic foot
3. The unit rate for large, open-volume, single story spaces in buildings, such as barns, silos, greenhouses, warehouses, distribution centers, and other agricultural, and storage-use occupancies..... **.035** per cubic foot
 - a. The calculated height shall be limited to 20' (plus below floor calculation) for uses listed in #3 above.
4. Use groups of single-family detached R-5 construction..... **.040** per cubic foot

B. Reconstruction, Alteration, Renovation, Repair

1. Fees shall be based upon the estimated cost of work.

- a. Estimated cost of work shall be computed per N.J.A.C. 5:23-2.15(a)4 and N.J.A.C. 5:23-4.20(c)2i3
 - b. Where any material or labor proposed for installation in the building or structure is furnished or provided at no cost, its normal or usual cost shall be included in the estimated cost.
 - c. If requested by the Construction Official, for the purpose of determining estimated cost, the applicant shall submit to the Construction Official such cost data as may be available produced by the architect or engineer of record, or by a recognized estimating firm, or by the contractor. A bono-fide contractors bid if available shall be submitted.
 - d. The Construction Official shall make the final decision regarding cost.

3. The plan review fee shall be **20%** of the amount to be charged for a new construction permit.

This is also the plan review fee for prototype plans.

4. When plans have been reviewed and released by the State of New Jersey DCA, the permit fee

shall be reduced by 20% from the amount otherwise specified in our fee schedule.

5. Plan review fees are non-refundable.

H. An administrative fee of 55% shall be assessed on each permit fee for each sub code performed by a third-party inspection agency

I. In order to support the maintenance and software licensing fees associated with the electronic permitting system a surcharge fee shall be collected in accordance with N.J.A.C. 5:23-4.22 and shall be as follows.....
\$1.00 per \$1000 value of construction

a. Minimum fee for electronic plan review shall be \$2.00

7. General Provisions

A. The fee charged for a construction permit will be the sum of the basic construction fee computed in accordance with the fee schedule herein, plus any applicable special fees, such as but not limited to sign fees, racking, etc. This fee shall be paid before a permit is issued.

B. The fee charged for a certificate of occupancy shall be paid before a certificate is issued. This fee shall be in addition to the construction permit fee.

C. All other fees not specifically covered by this section shall be in accordance with N.J.A.C. 5:23-4.

D. Fees shall be rounded to the nearest dollar amount and all fees are shown in whole US dollars, except as indicated otherwise, such as Building fee section A.

E. The elevator sub code is the jurisdiction of the Department of Community Affairs (DCA) for plan review and inspection. Application shall be submitted to the DCA.

[D.] Report of the Construction Code Official. As required by the State Uniform Construction Code

Act, as frequently as is required by the Act, the Construction Code Official shall, with the

advice of the subcode officials, prepare and submit to the Township of Florence, a report

recommending a fee schedule based on the operating expenses of the agency and any other

expenses of the municipality attributable to the enforcement of the State Uniform Construction Code Act.

Section 2. If any section, paragraph, subsection, clause, or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.

Section 3. All ordinances or parts of ordinances of the Township of Florence heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 4. This ordinance shall take effect immediately upon adoption and publication of notice of adoption as provided by law.

An Ordinance of the Township of Florence Amending Section 64-3 of the Code of the Township of Florence Establishing Construction Code Fees within the Township of Florence

Take Notice that the Ordinance identified above which amends the Florence Township Code to adjust the construction code fees, has been introduced on first reading by the Township Council of the Township of Florence, County of Burlington, State of New Jersey, held on August 5, 2026. It will be considered for final passage after public hearing to be held on September 2, 2026, at 7:00 P.M. in the Municipal Complex, Council Chambers, 711 Broad Street, Florence, New Jersey.

The Ordinance will take effect immediately upon adoption and publication as required by law.
