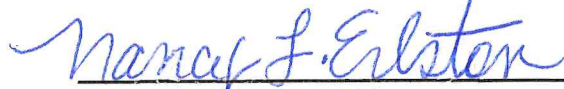
AUTHORIZING REFUNDS OF CERTAIN TAX OVERPAYMENTS
