**A RESOLUTION FIXING THE COMPENSATION  
OF CERTAIN OFFICIALS AND EMPLOYEES OF THE  
TOWNSHIP OF FLORENCE  
FOR THE YEAR 2026**

**BE IT RESOLVED**, by the Council of the Township of Florence, County of Burlington, State of New Jersey, and it is hereby enacted and resolved by the authority of the same:

**Section #1)** Based upon determination by the Township Council to set the salary of those employees not covered by a bargaining agreement, the Township Council does hereby establish for the calendar year 2026 the annual salaries for the employees specified on Schedule "A" attached, which salary shall be prorated according to the period of time the employee served in the particular position or title during the calendar year.

**Section #2)** The Township Clerk is hereby directed to forward a copy of this Resolution to the Chief Financial Officer of the Township of Florence in order that she may be made aware of the salaries herein supplied.


**Section #3)** The Chief Financial Officer is hereby authorized to promulgate the salaries upon adoption of the 2026 municipal budget.
