Whereas, the Township of Florence has the need on a timely basis to purchase goods or services utilizing State contracts; and

Whereas, the Township of Florence intends to enter into contracts with the attached Referenced State Contract Vendors through this resolution and properly executed contracts, which shall be subject to all the conditions applicable to the current State contracts;

Now, Therefore, Be It Resolved, that the Township of Florence authorizes the Purchasing Agent to purchase certain goods or services from those approved New Jersey State Contract Vendors on the attached list, pursuant to all conditions of the individual State contracts; and

Be It Further Resolved, that the governing body of the Township of Florence pursuant to N.J.A.C. 5:30-5.5(b), the certification of available funds, shall either certify the full maximum amount against the budget at the time the contract is awarded, or no contract amount shall be chargeable or certified until such time as the goods or services are ordered or otherwise called for prior to placing the order, and a certification of availability of funds is made by the Municipal Treasurer; and

Be It Further Resolved, that the duration of the contracts between the Township of Florence and the Referenced State Contract Vendors shall be from January 1, 2024 to December 31, 2024.
