WHEREAS, the Township Council authorized the Township Water and Sewer Engineer, Richard A. Alaimo Association of Engineers, with Russell Trice, P.E., to prepare plans, specifications and obtain bids for Electrical Improvements to the Wallace Avenue Pump Station; and

WHEREAS, the Township Water and Sewer Engineer, Russell Trice, received bids on June 16, 2017; and

WHEREAS, the Township Water and Sewer Engineer has recommended (see Schedule "A" attached) award of the contract to the lowest, most responsible bid for Electrical Improvements to the Wallace Avenue Pump Station to Ronald Janney Electrical Contractor, Inc., 143 Cumberland Avenue, P.O. Box 173, Estell Manor, NJ 08319: \$72,775.00; and

WHEREAS, the Township Council has reviewed the design plans prepared by the Township Water and Sewer Engineer and the project design is approved by the Township Council in accordance with those plans, subject to field changes approved by the Township Water and Sewer Engineer and Change Orders approved by the Township Council; and


